We met with PJI's Executive Director, Cherise Fanno Burdeen this past summer to discuss pretrial reform and how MAPSA can be valuable to your agencies and others across the state. PJI has been working with three states on the SMART pretrial demonstration initiative which will test the cost savings and public safety enhancements that can be achieved by improving pretrial policies and practices. We hope to continue to have discussions with PJI moving forward. Some board members recently met with research analysts from the State Court Administrator's Office. The Judicial Branch is conducting a statewide study on evidence based tools utilized in making pretrial release decisions. MAPSA is excited to collaborate with the state to collect the information and hopefully help move forward with the outcomes.

MAPSA's Fall Training "Evidence Based Pretrial Risk Assessments" was held at the Sherburne County Government Center on November 18, 2014. Daniel B. Ryan facilitated the training. Mr. Ryan became involved with MAPSA in the summer 2014. He has a history of training United States pretrial services and probation officers and has taught criminal justice courses at The University of New Haven and Long Island University. Mr. Ryan's training focused on the benefits of utilizing a pretrial risk assessment tool, with much discussion about how one tool may not work for all Minnesota agencies. The involvement and variety of attendees was great and the discussion about pretrial practices in Minnesota was valuable.

We hope to continue to gather information, collaborate with other organizations and educate ourselves on pretrial practices. Please contact MAPSA if you are interested in becoming involved.

Advancing safe, fair & effective pretrial justice practices & policies.

In yesterday's mid-term elections, New Jersey voters overwhelmingly passed Public Question No. 1 to amend the state constitution allowing for the preventive detention of pretrial defendants deemed high-risk for flight or public safety through a pretrial risk assessment.

The ability of New Jersey's courts to detain the most dangerous defendants through due process and with the assurance of a speedy trial is an historic move for the Garden State. What's more, it is a step toward repairing a broken pretrial system that has failed the state on two dimensions: it has allowed for dangerous defendants to buy their way out of detention and has resulted in the detention of many low-risk defendants for the lack of small sums of money.

The ability to preventively detain high-risk defendants complements legislation passed earlier this year that will establish pretrial services units to conduct pretrial risk assessments and provide supervision and monitoring to the defendants who are released before trial. In other jurisdictions where courts can detain based on risk, a vast majority –about 93%– are deemed appropriate for release.

The historic victory in New Jersey would not have been possible if not for the hard work of advocates and stakeholders in the state, particularly the leadership on this issue from the New Jersey office of the Drug Policy Alliance.
